2018-2019 SPONSORSHIPS

GOLD SPONSORSHIP (limited to six)

SILVER SPONSORSHIP (limited to 12, at least two from each of ATY, CPA and QFA disciplines).

A Silver Sponsorship runs the entire BEPC year (July 1st through June 30th) and includes:

- **Banner recognition** at all BEPC functions during the year.
- **Website advertising** with your company's name listed on the Patron page of the BEPC website along with a link to your company's webpage.
- **First consideration** for the silver sponsorship level for the 2019-2020 year.

The annual Silver Sponsorship level fee is \$1,000.

ANNUAL MEETING and/or SPECIAL EVENT SPONSORSHIP

- **First consideration** for the annual meeting sponsorship level for the 2019-2020 year.

The Annual Meeting or Special Event Sponsorship level fee is \$2,000.

In order to have all recognition material printed in time for the first BEPC fall program, sponsorship commitments for this year **must be received no later than Friday September 14, 2018** Payment for Silver Sponsorships is due by September 14, 2018.
